The VA is expecting a two to 2 1/2-year construction timeframe. Services to be offered are: Patient Aligned Care Team (PACT) Clinic; Audiology & Speech Pathology; Mental Health Services; Mammography; Multi-Specialty Clinic for Podiatry, Physical Medicine and Rehabilitation (PM&R); Prosthetics & Sensory Aids; Home Based Primary Care; Radiology Services; Pathology & Laboratory Medicine Services; Pharmacy; and Support Services.

Election Season Is Here—What You Need To Know

Early voting, mail-in ballots, voter registration. Does it all sound confusing? Learn what you need to do using the Citrus County Supervisor of Elections website before the Nov 5th election day:

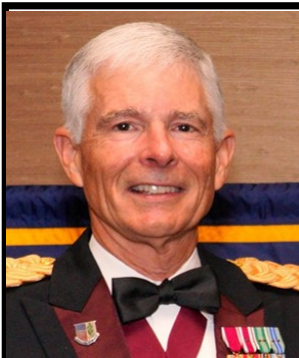
